The Shepherd's Center of Richmond is a close-knit community – a kind of flock, if you will. This year brought changes both wonderful and heartbreaking.

In July the Center welcomed its newest staff member, Lori DeLay, who now serves as finance manager.

In September the Center enjoyed its Annual Volunteer Celebration at Deep Run Park. We met in person to honor volunteers, see friends, and make new acquaintances.

October, however, brought heartbreak. We unexpectedly lost our board president, Stephanie Churchill, only four months into her new role. Stephanie was eager to lead, full of passion, and blooming with new ideas for growth and service. Her loss was painful for us all. In need of an interim leader, the Center was fortunate to have Hal Costley, long-time Shepherd's Center volunteer, step in to serve – once again – as board president.

Soon after Stephanie's loss, Vice President Kindall Bundy made the personal decision to resign. Once again in need of interim leadership, another long-time Shepherd's Center volunteer, Peter Pettit, graciously stepped in to serve as vice president.

In the spring, after a long shutdown due to COVID, we were grateful to be able to reopen Client Services to new clients in need of rides to medical appointments and grocery stores.

March brought more heartbreak: the loss of Betty Ann Dillon, a stalwart and dedicated Shepherd's Center volunteer, board member and past president. Betty Ann passed away peacefully after a long life of service and dedication. We think of her often.

The year overall brought three successful sessions of Open University. Classes and lunch speakers continued in person and online – a happy hybrid blend for those who wanted to stay home as well as for those who wanted to get out!

Several large bequests helped fund the purchase of new Open University and Shepherd's Center office equipment, as well as a cache of exciting new logo items.

The Center remains strong, flocking together, looking ahead, and moving forward. We welcome new members, students, volunteers, and donors.



ROBERT S. SEILER LEGACY SOCIETY

The legacy society of The Shepherd's Center of Richmond is named for the late Rev. Robert S. Seiler, founder and first executive director of the organization. Seiler, an ordained Episcopal priest, recognized early on that the growing population of older citizens in this country would have increasing needs. Following the model of Shepherd's Center of America that had its origins in 1972, he pursued ways to establish lifelong learning opportunities and set up services, like transportation, that might enable seniors to stay for a longer period of time in their homes. Working tirelessly with local congregations and with Virginia Commonwealth University, Seiler launched The Shepherd's Center of Richmond in March of 1984 as a nonprofit education and service organization for older adults.
